4. The applicant **must not mention his/her name or make any other identifying reference** within the essay, on the essay, or Part IV. **Failure to comply will result in disqualification.**
5. On the form sent to the Regent, each winner **must submit the name and address of the institution he/she will attend.**
6. “No” email applications will be accepted. **All application must be sent by Certified Mail** or given in person in an envelope.
  
7. All applications and essays must be postmarked no later than March 30, 2024.
